

MADISON COUNTY UNCLAIMED PROPERTY NOTICE

Texas Property Code, Title 6, Chapter 76 requires County Officials to report and remit abandoned or unclaimed property valued at \$100 or less to the County Treasurer. The County Treasurer is required to record all property types and dollar amounts and to post a notice stating the owner name and city of last known address. A list of all property owners with a monetary value of \$10.00 or more have been included in this notice, although there are owners with monetary values of less.
