Sheriff Adams stated they had a couple of incidents where they had to send someone out of state to pick up an inmate, not everyone has a personal credit card to be able to pay for hotel reservations, gas, and food. It is good to have for emergencies, and a policy will be put in place for the credit card usage. Toni Joyner, Auditor, stated that the credit card needs to meet the state purchasing guidelines and anything on that card that is not within guidelines as the elected official Sheriff Adams will be held accountable. Judi Delesandri, County Treasurer, added that if time permits to get an advancement unless it is an emergency.

Young Survey, Abstract 0245, Tracts 29 (24.7 acres), tract 28 (15.5 acres), tract 5 (24.7 acres) and tract 6 (74.1 acres). See attached.

Shelly Butts stated that this is combining and redividing a strip of land that shows the tree line the family has been taking care of to block the smells from Monterey Mushroom and they want to keep it, so they don't have to worry about the new owners removing it. The part that is on Highway 75 is a separate tract they want to join that tract, but Laura from the Appraisal District said she can create a new account and link it to another account, but she can not join them without having a whole new survey done. So that is why they are asking for a variance. The properties are adjacent, and the same owner will own both tracts, but one does not have road frontage. Commissioner Cannon asked about not being able to sell the tract with no road frontage. Shelly said by state law they can not sell land lock property without providing an easement.
