ITEM 5. Discuss and consider request from Madison County First Responders for HOT funds in the amount of \$1,000 for the Madison County First Responder's 2nd Annual Barrell Race. See attached. Judge Osborne said First Responders asked to rescind their request for HOT funds, they have enough sponsors to cover expenses for this event.

ITEM 6. Discuss future Commissioner Court dates and times for FY2023.

Judge Osborne said there had been public comment in the past of not being able to have time to research items that were coming up before the court, so discussed changing day and time for meeting with clerk and commissioners. One suggestion would be to move the meetings to Wednesday. Notices would be posted on Friday and that would give the public time to research agenda items before meeting on the following Wednesday. There is no action on this today, just a discussion. Wednesday works good for the clerk's county court and criminal court dockets, he said. Commissioner Cannon said Wednesday at 9:30 a.m. sounds good, other commissioners agreed. Judge said final decision and approval will be at one of the commissioners' court meetings in September 2022.

Judge Osborne said their budget is substantially larger than last year, but they are adding a new position. Commissioner Cannon said we have not approved this in the past when they had a significant increase, the percentage increase is excessive. Judge Osborne said the percentage increase is 16.91 percent, total budget increase \$133,094.00.

Commissioner Cannon moved to not approve; Commissioner Pohorelsky seconded the motion; and Judge Osborne called for a vote to not approve Madison County Appraisal District's Budget for FY2023, all in favor.
