ITEM 27. Discuss and consider Request for Acceptance of Culton Lane as a Private Road. See attached. Shelly Butts, Subdivisions/Rural Development explained this request for a private road dedicated as Culton Ln., Madison County, situated within property known as Madison CAD Property ID's 45074 owned by Tommy Culton, 45072 and 45073 owned by Peggy Culton and 36568 owned by Marlan and Lolita Brown. Mr. Culton requests commissioners court approve the designation of Culton Lane as an official private road in Madison County and understands that the county if not responsible for the construction or maintenance of said road. "Let it be known that this document does not provide access onto nor through any of the properties listed, nor any other properties. This only provides a 911 designation to the road for emergency related concerns" Butts said.

ITEM 28. Discuss and consider Minor Final Plat with Variance for property recorded in volume 275, Page 19, volume 830, page 10, volume 1873, page 268, number 118418, volume 1874, page 318, number 118476 and volume 1884, page 160, number 118898 of the Madison County records. Located in Rebecca Robbins Survey, Abstract 0188, Tract 18, Tract 17 (PT), previously divided. See attached. Shelly Butts, Subdivisions/Rural Development Coordinator said the reason for reference to these properties is because subdivision rules were not followed at the immediate time of division. This is taking 33.62 acres tract dividing into two tracts, a 23.61 acre tract and ten acres being further divided into two tracts, each five acres. The five acre tract off of FM 2158 has road frontage, but the other five acre tract does not have road frontage, so a variance is requested. The same landowner owns both five acre tracts which are continuance and Madison County Appraisal has agreed to accept this minor plat, Butts said.
