Shelly Butts, Subdivisions/Rural Development Coordinator said this is an original 4.683 acre tract and the owner is taking off a 1.021 acres a division resulting in the creation of two lots. The 1.021 acres tract has enough road footage, the residual tract has an 80-foot road frontage, and the division meets all county rules and regulations as a minor plat, she said.
