#### ITEM 16. Elections Administrator-Janet Boone

Boone gave an update on early voting turnout saying compared to 2016 early voting our county has a 50% increase in voters. She projects with election day 30% of registered voters in the county will have voted. Early voting ends Friday, February 28, 2020, vote centers are North Zulch School and Madison County Courthouse J.P. courtroom.

Larry Figley, Bedias, Texas addressed the court requesting approval of a Proclamation for the month of April to be proclaimed Confederate History and Heritage month. As a part of his presentation he made a statement saying "we look where we are in the world, we can see our history being destroyed and ripped apart".

Lee Roy Lance, Jr., Retired Navy Captain, Bryan, Texas addressed the court and as part of his presentation said, "more than 200 Confederate veterans are buried in Madison County, these veterans and their memories should not be forgotten, they deserve to be honored". "Yes, you can rewrite history, but it will not change what has gone on before us," he said.

George Cheek, Boerne, Texas American Legion Post 313 signed a participation form but declined to speak.

John McCammon, American Legion Post 313, Boerne, Texas said this Proclamation is important to the history of Madison County and its veterans should be honored.

Judge Leago explained Allison, Bass & McGee is the same company Madison County contracted with in redistricting 2010 census. The precinct lines will most likely be redrawn as a result of the 2020 census, he said. See attached.

ITEM 25. Discuss Bounty Program to help reduce the feral hog invasion in Madison County. Judge Leago said there has been several citizens from the county who have come forward requesting a county plan to control feral hogs. A bounty program was a suggestion by the Madison County Beef and Forage Committee made during a January meeting of Commissioners' Court. Judge Leago called on Chadd Caperton, Madison County Extension Agent for his input on feral hog programs. Judge said first, is the state engaged in doing something about this problem and secondly, what are other counties doing. Caperton said the state is not involved in research of toxicants, but A&M Agri Life Research Agency is testing a new toxicant, it's not approved and there's no information on it. The state had tried a poison, Warfarin, but it did not receive final approval. One of the big hurdles is recreational hog hunting in the state, it's a money maker and that group is opposed to a hog program. There are some counties that have hog programs and they vary as widely as the counties do themselves. Some have bounty programs, they put a bounty on hog parts, but I have heard negative feedback on it. Others have professional trappers and some personal hog traps. Caperton said he did not know if there are any grants allocated for hog programs. Judge said, if you've got deer stands pumping corn all around, you're going to have feral hogs. The best solution is net wire for fencing, Caperton said. Judge asked Caperton if he had an opinion on what's best for our county. He suggested contracting with a professional who has corral traps and knows how to catch multiple hogs at a time. Judge said we should table this discussion now and come back to it at next commissioner's court. Agenda item was tabled.
