ITEM 1. INVOCATION AND PLEDGES OF ALLEGIANCE TO THE FLAGS

The invocation and pledges of allegiance to the United States and Texas flags were led by Judge Leago.

ITEM 2. CALL THE MEETING TO ORDER

The meeting was called to order with a quorum present.

ITEM 3. Public Comment-Hear Comments in reference to the following Agenda Items Only-time limit three (3) minutes, one person at a time will be called from the Public Participation Forms submitted. Move to the front of the Court and stand at the podium.

No public participation forms were submitted.

ITEM 4. Discuss and consider extending Declaration of Local Disaster.

Judge said, we have approved this Declaration of Local Disaster several times before and this coronavirus pandemic is not over, so we need to extend this local disaster declaration because it expires today. He called on Shelly Butts, Emergency Management Coordinator to explain the advantages of having this Declaration of Local Disaster. She said, as long as we are under a local disaster declaration we are able to use emergency orders, able to use emergency purchasing procedures and as long as we keep the local disaster declaration in place it shows the state that we are in a position to request assistance in the future, financial or other. Judge said we are complying with the state and have received a vast number of emergency supplies. Butts currently has an order for 15,000 more surgical masks, hand sanitizer, and other items. We have been taking supplies to the nursing homes, hospital, assisted living and other places as needed. There will be another COVID-19 testing, a walk-up testing at

the Madison County Lakehouse Monday, May 29, 2020, appointments are not necessary. If a person is not having any symptoms but wants to be tested, they can do walk-up testing, she said. Judge Leago said before court takes any action, he would like to read into record a portion of the Declaration of Local Disaster beginning at "Now, therefore, be it proclaimed by the Commissioners Court of Madison County". Concluding, Commissioner Driskell made a motion to pass and approve the Declaration of Local Disaster; Commissioner Pohorelsky gave a second; and Judge called for a vote.
