ITEM 20. Discuss and consider project award for construction project for the 2016 Floods CDBG-DR Drainage Improvements. Three bids are attached.

Judge Leago said this construction project for the 2016 Floods CDBG-DR grant had to be re-bid. Judge Leago explained that this is another grant that we are positing ourselves in line for; and this is brought to commissioners' court because of the scoring of five companies who applied for the professional engineering services. Each company was scored and two of them scored identical, GLS and Jones/Carter. Judge had received good recommendations on GLS company, but the county has used the engineering services of Jones/Carter on another grant program and had a good record for its past performance.

ITEM 23. Discuss and consider action regarding County Health Insurance plan for 2020-2021. Daniel Anderson, Vice President of ANCO Insurance presented three bids of group health plans for the court's consideration as recorded in these minutes. He discussed each plan but said the Blue Cross Blue Shield has the best option on the table than the plan you have now. The BCBS will limit out-of-pocket expenses for employees to \$1,800, other plans were higher. Employees will be responsible for the first \$1,000 in costs, Anderson said this plan is a richer benefit. Two years in a row the county has had a decrease in cost for health care and no one else is seeing a decrease in costs, Anderson said. Commissioner Pohorelsky moved to approve Blue Cross and Blue Shield Health Insurance plan for 2020-2021; Commissioner Cannon gave a second; and Judge Leago called for a vote.

ITEM 24. Discuss and consider quotes for needed repairs to the Madison County Library. See attached. Designated Representative Lynn Jeffries gave a report on the needed repairs to the Madison County Library. He had requested three quotes, but one company at last minute declined to give a quote, so two quotes were presented to the court. Auditor Toni Joyner said the court could waive the policy for three quotes and accept the two quotes. Commissioner Cannon asked if the library had funds available for this project, Judge said no. Judge asked Jeffries if the building and grounds had funds available, Jeffries said no, but asked if it could come out of contingency fund. Auditor Joyner said funds were designated in contingency last year for library repair and Judge agreed. Court waived the third quote and moved forward with two quotes. Commissioner Pohorelsky moved to accept and approve quote from B'n'R Enterprises, \$16,367.00; and payment paid from contingency fund; Commissioner Cannon gave a second; and Judge called for a vote.

ITEM 25. Discuss and consider approving final minor plat on land recorded in Volume 1539, Page 111, Number 98954 of the Madison County Records. Located in the Thomas Boatwright Survey, Abstract 0008, Tract 17-2. Directions to property: West of Madisonville, along FM 1452 E to Oak Forest Lane, known as 911 address 2879 Oak Forest Lane, Madisonville, Texas 77864, and a new address to be determined. See attached.

Shelly Butts, 911 Coordinator said there have been concerns voiced by area landowners about this division. Oak Forest Subdivision is comprised of two-acre tracts and across and not a part of that subdivision are larger tracts. One of those larger tracts had previously been divided and this application is requesting another division of 1.60 acres from a 5.643 acre tract. This property is not in a county approved subdivision, so adjacent landowners are not notified of this division. These parcels are not in the subdivision but are located right across from it and they utilize the same street, Butts said. Commissioner Cannon said there is not much we can do about this because it is not a county subdivision. Butts said this division does not go against any county policies.
