ITEM 1. INVOCATION AND PLEDGES OF ALLEGIANCE TO THE FLAGS

Commissioner Driskell said, "I, Ricky Driskell, move to adopt this budget of Madison County, Texas as presented this 2nd day of October 2020 and to become effective upon October 1st, 2020 for the 2021 Budget Year." Commissioner Carl Cannon gave a second to adopting the Fiscal Year 2021 Madison County Budget; and Judge Leago called for a vote.

Discuss and consider action on adopting Tax Year 2020 Maintenance and Operations Tax Rate of 0.5500/\$100 valuation and Tax Year 2020 Debt Service Tax Rate of 0 valuation of the total Tax Year 2020 Tax Rate of \$0.5500/\$100 valuation. Motion should be made in the following form: "I move that the property tax rate be decreased by the adoption of a tax rate of .55/\$100 valuation, which is effectively a 2.17% decrease in the tax rate. See attached.
