ITEM 21. Discuss and consider adjusting Grade 9 and Grade 10 maximum pay scale of Madison County's Compensation scale. See attached.

Commissioners reviewed a draft of the Compensation Scale. Commissioner Cannon asked about Mr. Quick, Road Hand-Heavy Equipment Operator, Precinct 2, listed in Grade 7 of the scale. The minimum salary hourly rate of pay is \$16.17 and the maximum is \$24.90, Quick is paid \$15.89 hourly. Toni Joyner, Auditor said Commissioner Wiseman, Pct. 2, does not have funds in this budget to pay Quick so will move him back to Grade 6 or request contingency funds to pay him from Grade 7. Commissioner Wiseman testified that Quick is dependable and has made a good road hand and heavy equipment operator. Judge Leago made a motion to allocate the funds from contingency to pay Quick from Grade 7; made a motion to move cap on Grade 9 to \$27.00 an hour from \$26.15; and made a motion to move cap on Grade 10 to \$30.50 from \$30.42 hourly. Commissioner Cannon gave a second to the motions and Judge called for a vote.

ITEM 23. Discuss and consider Resolution supporting new State Highway Loop (SL) 1853. A Resolution supporting new State Highway Loop (SL) 1853 was signed by Commissioners and Judge after Commissioner Cannon moved to approve the State Highway Loop 1853; and Commissioner Driskell gave a second. A copy of the Resolution is recorded in these minutes. Funding for the loop has been received and naming the loop 1853 was a historical idea because Madison County was formed from Grimes, Walker and Leon counties on January 27, 1853. TXDOT is projecting the project to begin around 2025. Judge called for a vote on the Resolution.

ITEM 24. Discuss and consider purchasing 8 voter kiosks from Votec to replace outdated equipment. See attached.

Janet Boone, newly elected Elections Administrator said the elections department is requesting to purchase 8 voter kiosks from Votec to replace outdated equipment and requesting monies from contingency fund for payment, a cost of \$8,520. Judge Leago asked Boone to elaborate on the new equipment. She said it will include a field station laptop, a label printer, card reader for use to check drivers' license and a new signature pad. The signature pad syncs with the laptop to ensure accuracy and privacy. In the past, a person voting in a primary election had to declare out loud to a poll worker their party affiliation, the new equipment will eliminate it because the voter makes their choice on the laptop in private.

Commissioner Driskell made a motion to approve the purchase of 8 voter kiosks from Votec and to make payment for the equipment from contingency fund; Commissioner Pohorelsky gave a second to the motion and Judge Leago called for a vote.
