Shelly Butts, Emergency Management Coordinator explained Intergovernmental Agreements with City of Madisonville, North Zulch Municipal Utility District, and City of Midway for a countywide Hazard Mitigation Action Plan through FEMA grant funds. She will be meeting with each entity to request approval of this agreement. Maximum amount to be paid by City of Madisonville is \$6,500; City of Midway, \$1,500; and North Zulch MUD, \$1,000.

Shelly Butts, Emergency Management Coordinator said she had spoken to commissioners about doing a Solid Waste Grant through the Brazos Valley Council of Governments, Texas Commission on Environmental Quality. Butts had tried to find a Household Hazard Waste provider, but the cost proved to be tens of thousands of dollars. So, it may be our best interest to ask for another tire collection, we did not do it last year and used our funds to do computer collections with the City. We will do computer collections again this year. Butts said she had spoken with a Vendor for tire collection at the rate of \$2,500.
