#### ITEM 13. Emergency Management Report - Shelly Butts

No report was submitted, but Butts commented on activity in getting Interlocal Agreements signed. Judge said it does appear that the grant activity is picking up, Butts agreed and said there will be more information presented on upcoming agendas.

#### ITEM 16. Elections Administrator-Janet Boone

Janet Boone, Elections Administrator said voter registration is picking up, it may be due to a group called Engage Texas, a non-profit organization, who are sending out voter registration cards from a very old voter list. Some people are getting upset because they are getting voter applications for deceased persons. Boone is required to process all voter cards wherever they come from, so her business is picking up. Judge asked for additional information about this group. Boone said she had looked them up but did not recall only to say they are a Texas group and all postage to mail these applications is paid by the State of Texas, \$1.30 per card.

#### Comment:

Karen Lane, Tax Assessor-Collector, and Deputy Clerk, Veronica Hunt, attended V.G. Young Institute of County Government's 2019 School for County Tax Assessor-Collectors November 11-14, 2019 in San Marcos, Texas. Lane received 14 hours of Educational Training including Ethics for Tax-Assessor Collectors. Hunt received 13 hours of Educational Training and Ethics for TAC. See attached.

ITEM 18. Discuss and consider for approval the County to authorize the submission of an application to update our Hazard Mitigation Plan and to appoint the County Judge as the Chief Executive Officer and Authorizing Representative to act in all matters in connection with the Hazard Mitigation grant.

Shelly Butts, Emergency Management Coordinator said this is more paperwork on a grant that Grant Works is working on that includes the county, City of Madisonville, City of Midway and North Zulch

Municipal Utility District to get the Hazard Mitigation Plan revised and updated. The date for completion of the application has moved from December 31, 2019 to March 31, 2020, but we want to get our application in as soon as possible. This Resolution will allow Judge Leago to act on behalf of the County in all matters in connection with the FEMA Mitigation Grant. Judge asked if this is out of the General Land Office grant, Butts said it is federal funds through the state's Texas Department of Emergency Management. See attached.

Shelly Butts, Emergency Management said this is on that same grant and with the Resolutions we have the City of Madisonville would pay \$6,500; City of Midway, \$1,500; North Zulch Municipal Utility District, \$1,000; and whereas it was \$28,000, the county would pay the difference. See Resolution attached committing Madison County to provide local matching funds to secure and complete the FEMA Hazard Mitigation Planning Grant. See attached.

ITEM 20. Discuss and consider request from the Madisonville Cemetery Association, Inc. for a resolution in obtaining County records for the purpose of research.

Judge Leago called on Clark Osborne, president of Madisonville Cemetery Association, Inc. board of directors, to voice his request. He explained his need to view county records for cemetery deeds to identify plot ownerships for his database. He requested a free log-in with the county's recording and indexing vendor, so he can research records when the clerk's office is closed. Susanne Morris, County Clerk, did not agree saying It would be setting a precedence, open the door for title companies and others to request a free log-in. After further discussion commissioners agreed to consider drafting an agreement strictly with Osborne. Judge Leago said for legality, county attorney would be asked to assist in preparing the draft. Commissioner Cannon suggested making the agreement exclusively for Osborne, Judge agreed. Commissioner Driskell moved to prepare a draft agreement exclusively for Osborne's use; Commissioner Cannon gave a second; and Judge called for a vote.
