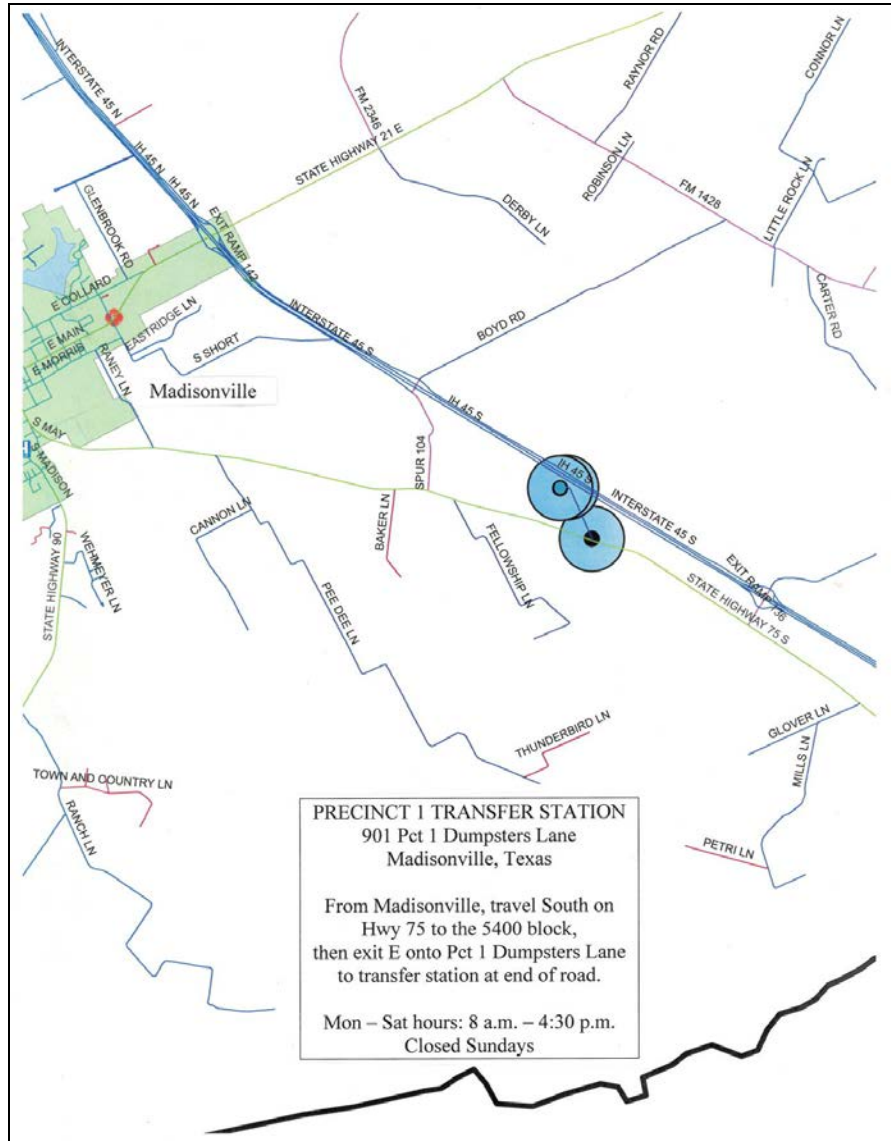

MADISON COUNTY PRECINCT 1 TRANSFER STATION LOCATION



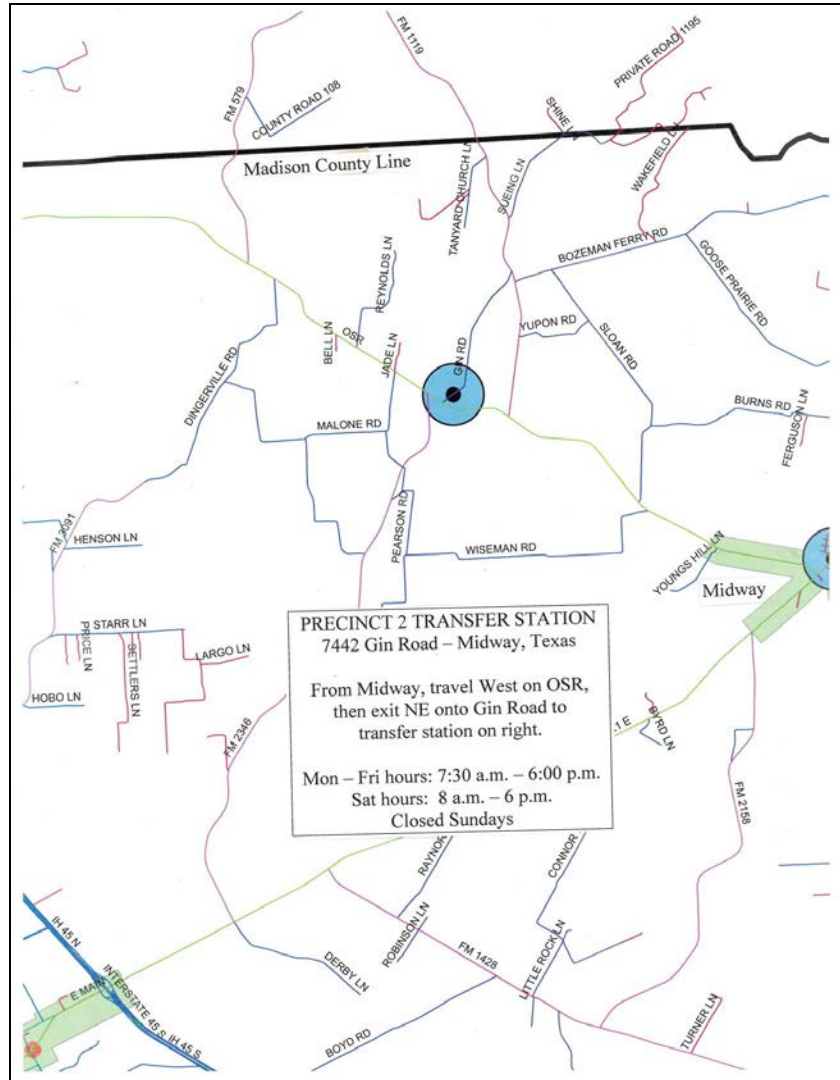

MADISON COUNTY PRECINCT 2 TRANSFER STATION LOCATION



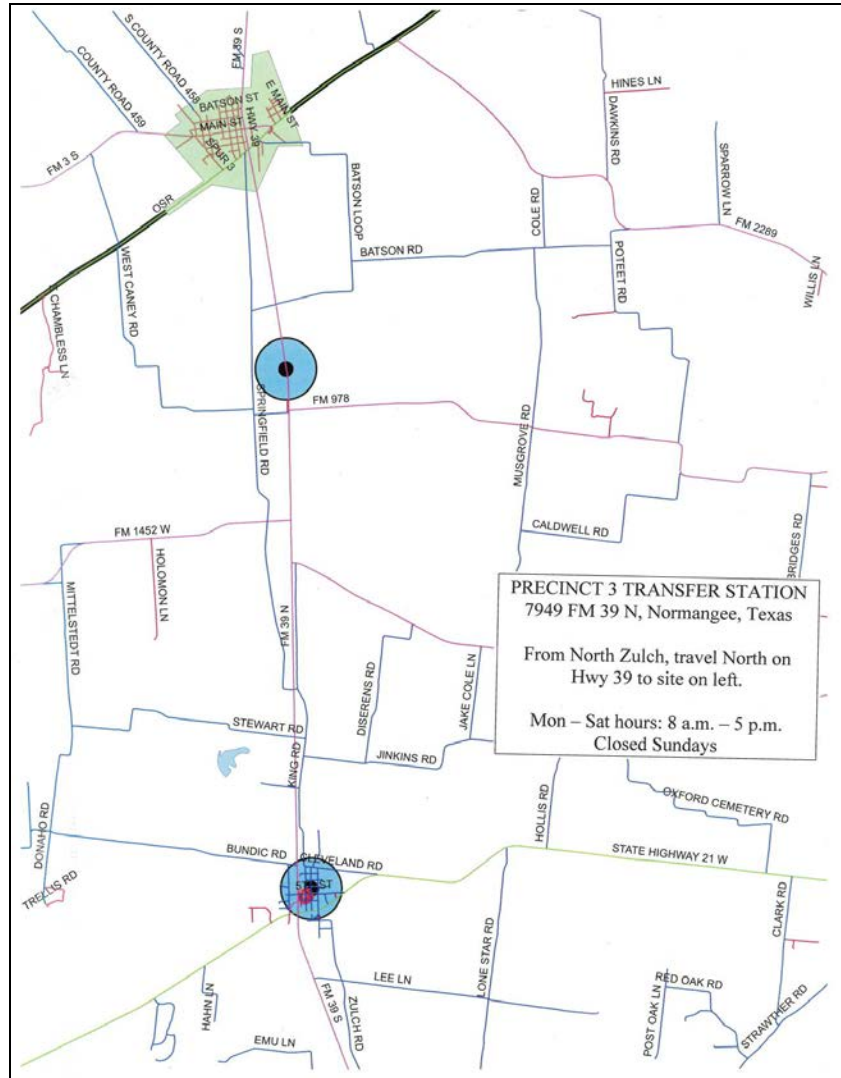
