

EXTENDED DECLARATION OF LOCAL DISASTER FOR PUBLIC HEALTH EMERGENCY

WHEREAS, beginning in December 2019, a novel coronavirus, now designated as COVID-19, was detected in mainland China, and has since spread throughout the world; and

WHEREAS, the World Health Organization declared COVID-19 is a worldwide pandemic on March 11, 2020; and

WHEREAS, there is a potentially imminent threat to Madison County resulting from the rapidly growing spread of COVID-19; and

WHEREAS, County Judge Tony Leago ordered a Declaration of Local Disaster for Public Health Emergency on March 16, 2020; and

WHEREAS, the County Judge and Commissioners Court of Madison County has determined that extraordinary measures must be taken to contain COVID-19 and prevent its spread throughout Madison County, Texas; and

WHEREAS, on March 19, 2020, the Madison County Commissioners' Court met in Special Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days; and

WHEREAS, on April 13, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days beyond April 18, 2020.

WHEREAS, on May 11, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond May 18, 2020.

WHEREAS, on June 18, 2020, the Madison County Commissioners' Court met at a Special Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond June 17, 2020.

WHEREAS, on July 13, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond July 17, 2020.

WHEREAS, on August 10, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond August 16, 2020.

WHEREAS, on September 14, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond September 15, 2020.

WHEREAS, on October 9, 2020, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond October 14, 2020.

WHEREAS, on January 11, 2021, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond January 13, 2021.

WHEREAS, on February 19, 2021, the Madison County Commissioners' Court met at an Emergency Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond February 13, 2021.

WHEREAS, on March 8, 2021, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond March 15, 2021.

WHEREAS, on April 12, 2021, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond April 14, 2021.

WHEREAS, on May 10, 2021, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond May 14, 2021.

WHEREAS, on June 28, 2021, the Madison County Commissioners' Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond June 14, 2021.

WHEREAS, on July 12, 2021, the Madison County Commissioner's Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond July 14, 2021.

WHEREAS, on August 9, 2021, the Madison County Commissioner's Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond August 13, 2021.

WHEREAS, on September 13, 2021, the Madison County Commissioner's Court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond September 13, 2021.

WHEREAS, on October 11, 2021, the Madison County Commissioner's court met at a Regular Session and deemed it necessary to extend the Declaration of Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond October 12, 2021.

WHEREAS, on November 12, 2021, the Madison County Commissioner's Court met at a Regular Session and deemed it necessary to extend the Declaration of the Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond November 12, 2021.

WHEREAS, on December 27, 2021, the Madison County Commissioner's Court met at a Regular Session and deemed it necessary to extend the Declaration of the Local Disaster for Public Health Emergency for an additional thirty (30) days, beyond December 12, 2021.


NOW, THEREFORE, BE IT PROCLAIMED BY THE COMMISSIONERS COURT OF MADISON COUNTY


1. That a local disaster was initially declared for Madison County pursuant to §418.108(a) of the Texas Government Code on March 16, 2020.
2. Pursuant to §418.108(b) of the Government Code, the local disaster shall continue for a period of not more than seven days (7) days except with the consent of the governing body of the political subdivision.
3. Pursuant to § 418.108(c) of the Government Code, this declaration of a local disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk.
4. Pursuant to §418.108(d) of the Government Code, this declaration of a local disaster continues the activation of the county emergency management plan.
5. That this proclamation shall take effect immediately from and after its issuance and shall be related to activities that have occurred and will occur in conjunction with the event described above.

Madison County Commissioners' Court has officially extended the Declaration of Local Disaster for Public Health Emergency for thirty (30) days from January 11, 2022.


