Shelly Butts, Subdivisions/Rural Development Coordinator explained this application is a request for replat of an already established subdivision and following 30-day comment period there were no replies from surrounding landowners. Shelly Butts, Subdivisions/Rural Development Coordinator explained this division results in four lots, it includes an area that is designated as a floodplain area by FEMA. Development of Lots 3 and 4 require adherence to Madison County Floodplain Regulations at the time of development. Anyone purchasing Lot 3 and Lot 4 will have to abide by floodplain rules and regulations.
