Sheriff Bobby Adams gave a partial report, eleven days, January 20-31, 2022, reporting as follows: responded to 121 calls, made seven arrests, issued 22 traffic citations, and 48 traffic citation warnings.

Susanne Morris, Madison County Clerk submitted an educational conference history report from County & District Clerks Association for January 1, 2021, to December 31, 2021, approved hours, 72.45, including Probate Workshop, CDCAT seasonal meetings, Legislative meeting, and Vital Statistics conferences.

ITEM 20. Discuss and consider approval of ARP Act Funds in the amount of \$2,446.00 to replace freezer door at the county jail. See attached.

Judge Leago explained American Rescue Plan Act (ARP Act) Funds came from the U. S. Treasury and the county received one-half payment last year and will receive the other half payment this year, 2.7 million dollars. Understanding the ARP Act Fund grant was complicated, so we used caution in moving forward with it. Recently, the U. S. Treasury said ten million dollars may be used as lost revenue, the Grant Administrator has confirmed this information. The County Jail needs additional improvements and part of the funds will be used for that purpose, Judge said. Sheriff Adams explained the need for a new freezer door, the freezer is good, but the freezer door is rusted out and needs to be replaced, he said. Commissioner Wiseman made a motion; Commissioner Pohorelsky gave a second to the motion; and Judge Leago said there is a motion and second to approve ARP Act Funds in the amount of \$2,446.00 to replace freezer door at the county jail, all in favor.
