Bobbie Duke, Elections Administrator explained the need for requesting funds from contingency due to expenses from four elections as follows: Constitutional Amendments Election/Special Election, Madison County Hospital District and Normangee School, November 2, 2021; Primary Election, March 1, 2022; Constitutional Amendments/Special Election, Normangee School and City of Normangee, May 7, 2022; and Primary Run-Off Election, May 24, 2022. ITEM 22. Discuss and consider adopting the use of a Mass Gathering Permit Application pursuant to the Texas Health and Safety Code, Section 9, Subtitle A, chapter 751.001.

Sheriff's Department Chief Deputy Curtis Klingle explained the Mass Gathering Permit Application. This application will follow state law governed by Texas Health and Safety. Event organizations from larger cities are coming into rural areas to promote their events and a number of other counties have adopted a similar permit application form. The permit application is required for events with 2,500 or more participants; or more than 500 persons. Madison County Judge is the administrator and will assign a health official, fire inspector and County Sheriff to perform inspections and set the number required for security. There is a big difference between a church gathering and a rap concert, we want the event organizer to provide a safe and secure environment for the event, Klingle said. See attached.
