Lynn Jeffries, Designated Representative submitted a Certificate of Attendance to the Texas on Wastewater Association, 2022 Annual Wastewater Conference, March 7-9, 2022, Galveston, Texas. He was awarded eleven continuing education hours.

ITEM 21. Discuss and consider Amber Alert, Network — Brazos Valley's request for FY2023 funding. Chuck Fleeger, Executive Director, Amber Alert Network Brazos Valley gave presentation reporting AANBV is a local non-profit organization focused on missing children/person issues in the Brazos Valley. Our organization was formed in 2003, and we have been a service provider to local law enforcement and families of the missing on a full-time basis since October 2020. These services include assistance with public notification, alerting decisions and activations, investigative consultation, outside agency liaison, search coordination, on-site response, and family services. Fleeger said services are currently funded by the Dansby Grant Foundation (a local charitable organization) Brazos County 911, Brazos County, City of Bryan, City of College Station and general community and individual support. As we begin to move into the preparation for the upcoming FY 2023 budget processes our organization is requesting funding from Brazos Valley counties, he said. As recorded in these minutes is a funding request of \$2,500.

ITEM 22. Discuss and consider using \$120,000.00 from the American Rescue Plan funds for salary increases for FY2022 to be effective beginning March 19, 2022, to the end of the FY2022 budget year for the Madison County Sheriff's Office employees.

Sheriff Bobby Adams said we are in a situation where we are not competing with Madisonville P. D. for law enforcement officers. We have lost officers to the P.D. and other counties because of pay. An officer who is leaving will be paid \$21.00 hourly, he was receiving \$16.78 hourly with the county. Commissioner Cannon said salary increases will not come from the budget but from the American Rescue Plan grant funds.

Commissioner Cannon made the motion; Commissioner Wiseman seconded the motion; and Commissioner Cannon called for a vote to approve\$120,000.00 from the American Rescue Plan funds for salary increases for FY2022 to be effective beginning March 19, 2022, to the end of the FY2022 budget year for the Madison County Sheriff's Office employees.
