ITEM 27. Discuss and consider Cost of Living Adjustment for Madison County Retirees and funding for such.

Toni Joyner, Auditor said retirement plans go by a calendar year, so any changes made have to be reported to Texas County & District Retirement System (TCDRS) by December 15, 2022. The court does not have to make that decision until later on, but it best to know so it can be built into the budget, the decision can be made now. Retirees do not get any cost-of-living adjustments unless the commissioners' court makes that election each year. Cost of living adjustments have not been brought to commissioners' court for a number of years until last year, the court approved funding. TCDRS computes the cost-of-living adjustments and amount for the retirees. Each year the demographics changes with retirees going on the plan and others coming off. Commissioner Cannon said so the advantage would be for you to know to build it into the budget; so how much did the county budget last year. Joyner said thirty percent of Consumer Price Index (CPI) and that has been the standard for past adjustments.

Commissioner Pohorelsky made a motion to approve; Commissioner McNutt gave a second to the motion; and Judge Osborne said we have a motion and second to build into the budget Cost of Living Adjustment for Madison County Retirees based on the previous trends, all in favor.

ITEM 28. Discuss and consider approving the use of Contingencies funds to pay an amount determined by Commissioners Court towards the FY 2022 unfunded balance to Texas County and District Retirement System.

Toni Joyner, Auditor said last year commissioners' court started the program and contributed an additional \$50,000.00 to the retirement plan to get our funding level from eighty seven percent closer to one hundred percent funded. We are at eighty seven percent funded, which is okay, we have favorable ratings, but we are not one hundred percent funded. It is reported on our financial statements, it is not out of line, but we do want to strive toward being one hundred percent funded for our liabilities. Last year commissioners court decided to make an additional \$50,000.00 deposit, one-time lump sum a year. This has not been done for Fiscal Year 2022, so if you want to make an additional deposit now would be the time to make that decision so it will be in next commissioners court payables, the check can get to TCDRS and credited to the county for the FY2022 year.

Commissioner McNutt made a motion to contribute \$50,000.00 to TCDRS from contingencies funds; Commissioner Cannon gave a second; and Judge Osborne called for a vote to pay \$50,000.00 from Contingencies funds to pay towards the FY 2022 unfunded balance to Texas County and District Retirement System, all in favor.

ITEM 29. Discuss and consider Application for Final Minor Plat with Variance for property recorded as an Affidavit of Exception to Madison County Land Platting Requirements in Volume 1686, Page 134, Number 108207, originally 183.6356 acres divided into six tracts known as the Jon Stevens Estates Subdivision dated 12/18/18 in the Madison County records. See attached.

Shelly Butts, Subdivisions/Rural Development Coordinator explained this subdivision application, minor plat requesting a variance. The original Jon Stevens Estates plat was over ten acres, but he is dividing 20.0775 acres being a portion of Tract 2, Tract 3 and Tract 4 and adjusting those tracts again. The reason for court's approval is because one of those tracts does meet the one to three, width to depth rule, the depth is more than three times the width. There has not been a recorded opposition to this application, she said.

Shelly Butts, Subdivisions/Rural Development Coordinator said you may recognize the Craig Stover property on Highway 90, application for minor plat. Original acres 5.873, said division resulting in the creation of two lots: 1) a 0.9222-acre tract and 2) residual acreage. New owner will abandon outdated septic system and install aerobic system.

ITEM 31. Discuss and consider quotes for upgrade to the county Managed Firewall System and licensing. See attached.

Judge Osborne referred to the three different quotes to consider. He said the current fire wall is reaching its end of life and will no longer be certified during any additional audits. Discussing with Dustin Price, Network Consultant for the county, said the new fire wall will bring us into the current century and compliance. More secure facets of the fire wall may be implemented gradually. Three quotes submitted are from CertNet Solutions, \$8,822.00; CDW, \$9,073.18; and Corporate Armor, \$10,809.48.

ITEM 32. Discuss and consider quotes for switch hardware and licensing for the Annex, Sheriff's Department and Courthouse and discuss funding for such. See attached.

Judge Osborne said there are three sets of quotes to be considered, Courthouse, Annex, and Sheriff's Department. This would replace the current switches and remove the old legacy router. In each situation we have quotes from CertNet Solutions, CDW, and Corporate Armor. All three quotes from CertNet Solutions were the least expensive, and there needs to be discussion on funding for such, he said. Toni Joyner, Auditor said payment would be from contingencies fund, but Donna Cuevas, Assistant to Judge, said it qualifies for ARPA (American Rescue Plan Act) funds. Judge Osborne said approving CertNet Solutions would be a total expense of \$37,248.00.

ITEM 33. Discuss and consider correcting the proposed tax rate, which was misstated during the August 8, 2022, Commissioners Court meeting and take a record vote. See attached.

Karen Lane, Tax Assessor Collector explained the software company made a change in their programming overnight which changed our rate, and I did not notice the change. The worksheets I presented August 8, 2022 commissioners court were correct, but the cover sheet was incorrect, it misstated our de minimis rate, so this is to correct that cover sheet, she said. Judge said so the twelve or so worksheet pages presented at last commissioners court is correct, and all this does is correct the cover sheet that picked up an incorrect value for all the rates. The incorrect de minimis cover sheet rate of \$0.4750 reported on August 8, 2022 has been corrected on this cover sheet to \$0.4864 per \$100 valuation. Lane said yes that is correct. Judge said there needs to be an agreement to correcting the cover sheet and take a record vote.

Commissioner Cannon made a motion to correct the de minimis rate to \$0.4864 per \$100 valuation; Commissioner Wiseman seconded the motion; and Judge Osborne said we have a motion and second to correct the proposed tax rate, which was misstated during the August 8, 2022 Commissioners Court meeting as \$0.4750 and change is to the corrected de minimis rate \$0.4864 per \$100 valuation and take a record vote, any further discussion, the court clerk will call the roll.
