ITEM 20. Discuss and consider entering into an Interlocal Agreement (ILA) between the Brazos Valley Council of Government and Madison County for: E9-1-1 Public Safety Answering Point Services; and E9-1-1 Database Maintenance Services.

Judge said this is a renewal agreement and asked Shelly Butts, Emergency Management Coordinator to explain. The Council of Governments (COG) provides the E9-1-1 Public Safety Answering Point services equipment at the Sheriff's Department and is constantly upgrading it. The enhanced 9-1-1 automatically displays the telephone number and physical location of the 9-1-1 caller. Madison County receives a \$20,000 grant for the database maintenance service each year.
