ITEM 19. Historical Commission - Clark Osborne

Osborne said Madisonville Cemetery Association signed a contract with Texas Department of Criminal Justice last week for maintenance services; and asked TDCJ if Madison County Historical Commission could have a contract for care of county rural cemeteries, but have not heard back from them, he said.

ITEM 20. Public Comment – Hear Comments in reference to the <u>following Agenda Items Only</u> – time limit 3 minutes, one person at a time will be called from the Public Participation Forms submitted. Move to the front of the Court and stand at the podium.

Two Public Participation Forms were submitted to the County Clerk. Kevin Counsil requested to speak on Agenda Item 21; and Arnold Foster asked to speak on Agenda Item 24.

Kevin Counsil, Republican Party Chairman and Election Executive Committee Chairman said the committee met Sunday, July 24, 2022, from 3 p.m. to 10 p.m. interviewing Madison County Judge candidates, there were fantastic applicants. The committee vetted them on their criminal history, voting history, community involvement and posed other questions. County commissioners were invited to attend and observe the interview process. Election Executive Committee came to a unanimous decision that Clark Osborne will be the Republican candidate for the office of Madison County Judge on the General Election ballot, November 8, 2022.

Arnold Foster representing Jozye Cemetery Association member of the Board of Directors for over twenty years began his comments by giving the history of Jozye community and cemetery created in the early 1900's. He voiced his objection and concern to Agenda Item 24, a 1.218-acre plat for a livestock holding pen adjoining the cemetery. The sight, sound and smell will be a nuisance for our cemetery. A cemetery should have an atmosphere of a peaceful place where family members may come to visit, and meditate, he said.

ITEM 22. Discuss and consider and vote on proposed tax rate for FY2023.

Commissioner Cannon called on Karen Lane, Tax Assessor-Collector to comment on the proposed tax rate for FY 2023. Lane said she has not received certified numbers to prepare calculations for truth-in-taxation. Whatever the court proposes for FY 2023 tax rate cannot go above that figure, you can go below, but once you decide on the tax rate you cannot go above it. Lane said she will need a record vote by the court. Commissioner Cannon said Toni Joyner, Auditor and Lane, TAC had advised \$.55 per \$100 evaluation for FY 2023 proposed tax rate.

Commissioner Pohorelsky made a motion to set the FY 2023 proposed tax rate at \$.55 per \$100 evaluation; Commissioner Wiseman gave a second to the motion; and Commissioner Cannon said we have a motion and second to set the proposed tax rate for FY 2023 at \$.55 per \$100 evaluation and called for a vote by each commissioner as follows:

Shelly Butts, Subdivisions/Rural Development Coordinator explained this division is for 13.875 acres together with a 30' wide access easement from a 140.5-acre tract. The request for variance conforms with width to depth ratio subdivision rules, she said.

Located in the Eduardo Arriola Survey, Abstract 0004, Tract 48, being 4.93 acres more or less known as 4747 Jozye Road, Madisonville, Texas 77864. See attached.

Shelly Butts, Subdivisions/Rural Development Coordinator explained this property is along Jozye Road, owner is taking 1.281 acres out of a 4.93 tract which is currently being used as a livestock transfer lot. Applicant is requesting a variance for width to depth ratio, 130' across the road frontage to a depth of 454'. The property meets all subdivision rules and regulations except for the width to depth variance. Commissioner Wiseman moved to deny this application for variance, width to depth ratio does not meet the 80' road frontage subdivision requirement; Commissioner Pohorelsky seconded the motion; and Commissioner Cannon called for a vote to deny Application for Final Minor Plat with Variance for property recorded in Volume 1636, Page 280, Number 105032 of the Madison County Records. Hillary Graham, Marketing and Tourism Director, City of Madisonville, explained this is a new event other cities do with their local parks, it will be from 5:00 p.m. to 10:00 p.m. It will be a community getto-gather with a fun run, vendors, food trucks, music, and DJ, it is free to the public. Participants from Houston, Dallas and San Antonio have registered for the fun run, and we have room blocks at two hotels, she said. Klingle said North Zulch School approached the Sheriff's Department in regard to hiring a school resource officer. They have proposed paying 75% of the deputy's salary, benefits, as well as vehicle and equipment.

They would have the deputy during the school year and the remainder of time the Sheriff's Office would have them for patrol duties or where every needed. The school would have an officer there all the time and they do have armed teachers as well. The goal here is school security, protect our kids and teachers, everyone working together, he said.
