ITEM 23. Discuss and consider approving Madison County's Hazard Communication Program. See attached.

Judi Delesandri, Treasurer, said recently, commissioners and employees were given an employee training program by a representative from Texas Association of Counties, TAC, and this is a copy of their sample policy they recommend we adopt. Judge Osborne said, so we have never had this program before, Delesandri said no. Judge said he has several questions about wording of the policy and for instance, who is responsible to maintain updates and provide the training. Commissioner Cannon said the county does not have hazardous chemicals in the workplace in excess of fifty-five gallons or five hundred pounds in aggregate amount. Commissioner Starr said the largest chemical used in our county is fuel, Commissioner Wiseman said, and oil. Commissioner Starr said if we develop a policy and do not adhere to and understand it, then it could become a liability. Judge Osborne and Commissioner Starr offered to work on this policy and present it at a future commissioner's court regular session.

Commissioner Pohorelsky made a motion to table this agenda item; Commissioner Wiseman seconded the motion; and Judge Osborne said we have a motion and a second to table this agenda item 23 to a future court date when the Hazard Communication Program policy has been further reviewed, all in favor.

ITEM 26. Discuss and consider Appointment of Madison County's Veteran Services Officer.

Judge Osborne said several applicants were interviewed for this position and called on Commissioner
Cannon to announce the officer selected. Commissioner Cannon said Erica Green is selected to be the
newly appointed Madison County Veteran Services Officer and made a motion to approve. Judge said
Green will be replacing retiree Danny Singletary who was budgeted to work sixteen hours weekly, but in
order to get VA authorization and login credentials there is a minimum of one thousand hours required.

We have had a reputation of underserving our veterans so to remedy that we are suggesting 29 hours weekly at \$16.00 per hour, effective January 3, 2023.

Commissioner Cannon amended his motion to approve the appointment of Erica Green as Madison County's Veteran Services Officer, 29 hours weekly at \$16.00 per hour, effective January 3, 3023; Commissioner Starr gave a second to the motion; and Judge Osborne said we have a motion and second to approve Erica Green as Madison County's Veteran Services Officer, 29 hours per week, at \$16.00 per hour, effective January 3, 2023, all in favor.

Located in the Rebecca Robbin League Survey, Abstract 0188, Tract 13, being part of a called 17.6 acre tract, known as 9037 FM 1428, Midway, Texas 75852. See attached.

Shelly Butts, Subdivisions/Rural Development Coordinator was not in attendance but had provided a statement requesting approval for land that has been inherited and is now being divided into two parcels. A previous division resulted in a separate 3-acre tract adjacent to these. The division meets the requirements of our current rules and regulations.

ITEM 29. Discuss and consider approving Madison County Solid Waste Disposal Rules for 2023. See attached.

Commissioner Starr had gathered information on solid waste disposal and found the county to be insolvent. He said income from dump permits is \$75,000, but the problem is county's cost for solid waste service, \$356,000; so, he suggested possibly an increase in permit fees, \$100.00. Commissioner Cannon remarked that would be around \$8.33 monthly for waste disposal. Karen Lane, TAC questioned the second sentence in line item two, placing the permit sticker on the windshield. Commissioner Cannon said as long as they have the sticker or proof of purchase, they should be allowed to use the facility. Commissioner Starr suggested changing the wording to proof of purchase will be required, it can be the sticker or receipt of purchase.

Commissioner Starr moved to approve the Solid Waste Disposal Rules for 2023, amending the annual fee to \$100, and striking second sentence of item two and replace with proof of purchase will be required to use county disposal facilities. Judge Osborne said currently we have a motion to approve the Madison County Solid Waste Disposal Rules for 2023 with the following changes, item two the fee will be changed from \$60 to \$100, and the second sentence, about the sticker being placed on the windshield, will be struck to be replaced by proof of purchase will be required to use county disposal facilities and asked Commissioner Starr if it is worded correctly, he agreed. Commissioner Pohorelsky gave a second to the motion and Judge said we have a motion and second to approve Madison County Solid Waste Disposal Rules for 2023, all in favor.
