ITEM 11. Designated Representative Monthly Report - Lynn Jeffries

Lynn Jeffries, Designated Rep. reported issuing eight septic system applications, fees totaling \$1,995.00 and issuing four health permits, fees totaling \$1,762.00.

ITEM 12. Tax Assessor/Collector Monthly Report - Karen Lane, TAC

Karen Lane, TAC submitted September 2022 monthly report, total funds collected, \$38,731.67; registration and title system fees for September, \$573,654.62; and Texas Parks & Wildlife boat titles, motor titles and renewals, fees for September 2022, \$3,951.16.

ITEM 13. Emergency Management Report - Shelly Butts

Shelly Butts, Emergency Management, 9-1-1, Subdivisions/Rural Development, Grants Coordinator submitted revenue for electric permits and address signs for a period of July 2014 through September 2022. Total electric permit fees collected for Fiscal Year October 1, 2021 through September 30, 2022 is \$9,960.00 and land division fees are \$9,170.00. Texas Department of Emergency Management has sent out the new Texas County Thresholds for FY 2023. FEMA set the threshold amounts for federally declared disasters for each county. Funding goes to the state level and then to the county level. Our county population is 13,455, so our losses would have to be at least \$59,740.20 to receive FEMA funding for any road damages or infrastructure damages, and it has to be uninsured losses. TDEM is encouraging everyone especially non-profits and school districts to keep tract of their losses. We partner with the Ag Extension Agency to get numbers on ag losses, crop losses, that kind of thing and encourage the public to keep tract and turn information into Emergency Management, Butts said. ITEM 14. County Extension Agent Monthly Report-Allen Homann

Judge Osborne introduced Ty Jordan, Ag Extension Agent partnering with Madison and Leon Counties, his position is one hundred percent funded by Prairie View A&M University. Jordan said Prairie View's plan for putting an agent in Madison and Leon counties is to help with the underserved agriculture community, women in ag, minority groups, and to target all people interested in Agrilife. Job duties include assisting sign up for USDA, FSA loans, helping with programs and grants Prairie View has to offer, Jordan said. He is located at the Madison County Extension Agent's office, 300 School Street, #101, Madisonville, Texas 77864.

ITEM 15. Veterans Affairs – Open Position

Judge Osborne reported Danny Singletary has resigned as Madison County's Veterans Affairs Officer and applications are open to fill this position. Pat Patterson, Veterans Affairs Officer, Brazos County suggested getting an officer that seeks a higher certification to provide more services to local veterans. There is a possibility of getting a van from V.A. to transport our veterans for their health care, financial or other needs or possibly use of a van from our Sheriff's Department, Judge informed.

ITEM 18. Sheriff's Department - Bobby Adams

Sheriff Bobby Adams presented Patrol Division, Deputy Monthly Activity Report for September 1-30-2022, 338 total calls, 10 total arrest by S.O., 23 total charges by S.O., 105 total citations, 137 total warnings, 54 total arrests to jail, and 0 serious incidents in jail. See attached.

Shelly Butts, Emergency Management Coordinator explained funding for the Regional Mitigation Program. Texas General Land Office allocated \$25,041,000 to Brazos Valley region for distribution to municipalities and counties. Madison County's amount of funding is \$600,000, however should an entity decline acceptance in the program that amount will increase. The acknowledgment of acceptance of declination of funds form is due today, she said.

ITEM 24. Discuss and consider request from the Sheriff's Department to destroy, donate or sell at public auction abandoned property which has been in the possession of the Madison County Sheriff's Office in excess of thirty (30) days.

Judge Osborne called on Calicla Kampf, Deputy, who explained she started this project in March 2022 to inventory abandoned property that has been in possession of the Sheriff's Department for multiple years. I have done due diligence and research on these abandoned property items; a majority do not have serial numbers and it would cost the county to go through the process at the tax office to get a serial number in order to sale an item on Swico Auction. Judge said, so Sheriff Adams and you are requesting permission to use your judgment as far as legal methods to dispose of this abandoned property, Sheriff and Kampf agreed.

ITEM 25. Discuss and consider application for final minor plat for property recorded in Volume 194, page 139 and Volume 1754, Page 283, Number 111944 of the Madison County Records located in the John Crist League Survey, Abstract 0011, Tracts 49 and 65, being 141.50 acres and 20.173 acres more or less.

Shelly Butts, Subdivisions/Rural Development Coordinator said applicant is joining two tracts, then dividing them into two separate tracts, tract one is an 80.902 acre tract and tract two is the residual. This application meets the requirements of the county's subdivision rules and regulations for a minor plat. The driveway may need to be moved due to a drainage issue; this area is not in a flood plain but there could be possible flooding on the property.

ITEM 26. Discuss and consider application and preliminary plat for property recorded in Volume 1816, page 107, Number, 15411 of the Madison County Records. Located in the James M. Harbour Survey Tract 1-5, Abstract 0109 of Willow Branch Estates with drainage considerations. See attached. Shelly Butts, Subdivisions/Rural Development Coordinator said she, Commissioner Pohorelsky, Pct. 4, Judge Osborne met with Doak and Jennifer Dunkin, developers and reviewed the plat. All of the lots now meet Madison County subdivision requirements without any variances requested. There are 14 property tracts ranging from 5 acres up to 48.87 acres. Survey plat shows utility lines, estimated flood plain from engineer's report and small creek areas. Engineer suggested no construction within fifty feet of the creeks. Deed restrictions are recorded on page two of the plat. Judge Osborne said the last time this application was submitted it was a 15-tract subdivision and each tract required a variance. The developers have gone back and redrawn the plat to 14 tracts meeting all the regulations with no variances required.
