ITEM 23. Hear Presentation from Bo Williams and Brandon Northcutt with MidSouth Fiber regarding their planned fiberoptic expansion in Madison County.

Bo Williams, Vice President of Operations and Engineering, Brandon Northcutt, Vice President of Internet Technology, and Will Bond, Fiber Sales Representative, of MidSouth Electric Co-Op gave a presentation regarding their planned fiberoptic expansion in Madison County. Williams gave background information on how MidSouth started its fiber business saying basically to connect the infrastructure on our electrical system, to implement some smart grid technologies, and to help the resiliency in our own network. To do so, we had to build a fiber system on all of our electrical poles, so, at this point our CEO and the Board of Directors decided to provide high speed internet to our rural membership, he said. In 2019 we opted to go into an internet service provider business, it took three years to complete. Electric is governed by the Public Utility Commission, so we cannot go across some lines, but for fiber internet we can cross lines. Our CEO is looking into building into some more rural communities and Williams presented maps on video screen for the court to review. We have built a small operation center office in Madisonville to get our corporate network looped together providing a way for new internet customers. We are working on three projects to loop in network from the Bishop substation, Bedias substation and North Zulch substation to offer internet services to other customers. Williams referred to the map and said this project will cost fifteen million dollars, and MidSouth has agreed to take on this project, government funding is not even five percent. Williams said we are looking to come up with a permitting process where we can put the fiber infrastructure in the county right-of-way; and had copies of other county permitting processes to view. Northcutt answered the question on rates for internet service, residential rates are 100 Mbps, \$64.95; 500 Mbps \$79.95; and 1 Gbps, \$99.95. Business rates are 100 Mbps, \$99.95; 500 Mbps, \$199.95; and Gbps, \$399.95.
