Courtroom and North Zulch School. Election Day is Tuesday, March 3, 2020, 7:00 a.m. to 7:00 p.m.

ITEM 23. Judge Leago explained this item of business had been tabled in a Special Commissioners' Court meeting, February 3, 2020, and the court requested an approval on location of the entry driveway because of the curve. Judge contacted the realtor explaining what the court requested before any action could be taken on this application.
