Karen Lane, TAC, reported total funds collected April 2020 was \$49,936.73. April 2020 Monthly Report, gives an account of Current Taxes Collected, Delinquent Taxes Collected, Fees Collected, Auto Registrations and Titles, and Texas Parks & Wildlife report. See attached.

ITEM 13. Emergency Management Report - Shelly Butts

At this time, 117 tests for COVID-19 have been initiated in Madison County, with two confirmed cases and 53 results still pending said Shelly Butts, Emergency Management Coordinator. Additional information is discussed in her Commissioners Court Report, May 11, 2020, as recorded in these minutes. Judge Leago said documents had to be submitted to the state for county businesses to open the doors at 50% occupancy instead of 25%. So much goes on behind the scenes the public does not know about, he said. He acknowledged the work of Butts, the City, Don Grooms and Lynn Jeffries in determining occupancy loads in each business.

Judge Leago said this Resolution has to do with the county updating its radio communication in which we are desperately in need of. He called on Shelly Butts, Emergency Management Coordinator to explain this grant. She said, if commissioners' court approves, the county will move forward to apply for a \$270,000 grant to upgrade communication systems for first responders. Brazos Valley Wide Area Communications System partners with Texas A&M, cities and counties operating a radio system that links law enforcement, fire departments, and medical services. The grant does not include maintenance of the equipment; the county would be responsible for that cost. The system currently in place is aging and needs to be replaced; it would upgrade our computer dispatch systems and connect with Walker and Brazos Counties.
