ITEM 15. County Extension Agent Monthly Report - Chadd Caperton

Leslie Lazenby, Extension Program Assistant, told about Dr. Billy Zanolini in 2011 developed the Ross Garrett Memorial Livestock Project. Mr. Garrett was a Madison County Agent for many years. The Ross Garrett Outreach Project is for minority and underprivileged youth in Madison County wanting to participate in the Madison County Fair, this program gives them the opportunity to raise a livestock project. Ross Garrett Outreach Project has grown due to the support of volunteers and donors. See attached.

Lazenby told about a number of exhibitors participating in the State Fair of Texas and Brazos County Fair, and there will be a number of agricultural exhibits set up at the Mushroom Festival this year. Currently, there are 10 Clubs chartered in the 4-H organization.

ITEM 16. Veterans Affairs – Danny Singletary

Since last reporting, Danny Singletary, Veterans Office for Madison County, assisted three veterans to medical facilities in Bryan-College Station; assisted one veteran with survivor benefits; assisted a vet with his discharge, received 12 hours continuing education hours and completed his annual Veteran's Administration examination.

Commissioner Driskell questioned the four percent raise for employees, saying in his opinion it should be three percent. Commissioner Cannon agreed with a three percent raise too. Toni Joyner advised that changes would create delays in the budget process. Counties have a deadline, September 30, 2019, to have an approved budget. Judge Leago said a Proposed Budget was posted on July 31, 2019, for review and any suggested changes. In the future you should bring up issues before time for the final budget to be approved. Order and copy of budget is enclosed in these minutes.

ITEM 21. Discuss and consider action on adopting Tax Year 2019 Maintenance and Operations Tax Rate of 0.5051/\$100 valuation and Tax Year 2019 Debt Service Tax Rate of 0.0449/\$100 valuation of the total Tax Year 2019 Tax Rate of \$0.5500/\$100 valuation. Motion should be made in the following form: "I move that the property tax rate be increased by the adoption of a tax rate of .55/\$100, which is effectively a 11.36 percent increase in the tax rate. ITEM 22. Discuss and consider action on ratifying that the adoption of the Fiscal Year 2020 Madison County Budget will raise more total property taxes than last year's budget by 13.57% an increase of \$203,828. The property tax revenue to be raised from new property added to the tax roll this year is \$747,430. See attached.

Commissioner Cannon moved to approve ratifying the adoption of the Fiscal Year 2020 Madison County Budget, I move we approve this Item 22; Commissioner Driskell gave a second; and Judge Leago read the Order Ratifying Tax Increase 2020. The budget will require raising more revenue from property taxes than in the previous year, so Commissioner Cannon moved to ratify the property tax increase as reflected in the 2020 Adopted Budget of Madison County, Texas and it was seconded by Commissioner Driskell. Judge called for a vote.
