ITEM 11. Designated Representative Monthly Report - Lynn Jeffries

Designated Representative Jeffries reported receiving in August 2020, 11 septic applications and fees totaling \$2,530. He reported that the building contractors are currently making repairs to Madison County Library.

ITEM 12. Tax Assessor/Collector Monthly Report – Karen Lane, Tax A/C

A monthly report for August 2020 was submitted by Karen Lane, Tax A/C as recorded in these minutes. See attached.

ITEM 13. Emergency Management Report – Shelly Butts No report was submitted.

ITEM 14. County Extension Agent Monthly Report - Chadd Caperton

County Extension Agent Chadd Caperton gave a report on 4-H members and their activities. Several members and their families will be participating in the State Fair of Texas and the Heart of Texas Fair. The 4-H clubs have started meeting and they are facing a few difficult challenges in abiding by the state policies and regulations during this pandemic, he said.

ITEM 15. Veterans Affairs – Danny Singletary No report was submitted.

ITEM 16. Elections Administrator-Janet Boone

Janet Boone, EA gave a report on voter registrations and mail ballot requests. She is assisting 50-60 persons weekly with voter registration, some are new voters, and some are updating their address. Currently I have received 350 mail ballots but expecting more. October 5, 2020 is the last day for voter registration and October 23, 2020 is the last day to request a ballot by mail, she said.

ITEM 17. Justice of the Peace - Steve Cole/Jon Stevens

Steve Cole, J.P. Pct. 2 presented his Distribution Summary report for fees collected for August 2020, totaling \$4,730.37 as recorded in these minutes. A Distribution Summary report, Jon Stevens, J.P. Pct. 1 was submitted with fees totaling \$33,370.60 as recorded in these minutes.

ITEM 18. Public Comment – Hear Comments in reference to the <u>following Agenda Items Only</u> – time limit 3 minutes, one person at a time will be called from the Public Participation Forms submitted. Move to the front of the Court and stand at the podium.

No Public Participation Forms were submitted to Clerk of Court.

ITEM 19. Conduct public hearing on proposed Fiscal Year 2021 Madison County Budget.

Judge Leago called the public hearing in session and opened the floor to anyone wanting to make a comment on the proposed fiscal year 2020 budget. There were no responses; Judge closed the public hearing.

ITEM 20. Discuss and approve adopting the Fiscal Year 2021 Madison County Budget. Commissioner Driskell said he wanted to make a change to the budget, to give 3% raise to all employees who make \$15.00 or less, employees making above \$15.00 do not get a pay raise. Judge asked for any other discussion on Commissioner Driskell's recommendation; we would approve the budget with that one condition. Commissioner Driskell said yes. Judge asked Commissioner Driskell to state that in the form of a motion. Commissioner Driskell said, "I Ricky Driskell move to adopt this budget for Madison County Texas with the consideration of the pay raises as stated for employees making \$15.00 or less on this 14th day of September 2020 to be effective October 1, 2020 for the fiscal year 2021 budget year". Commissioner Cannon gave a second. Toni Joyner, Auditor asked if she could interject, Judge recognized her. Joyner said this is going to make our publications that we ran in the newspaper ineligible and ineffective. It will require additional postings in the newspaper for all the elected officials, no elected official makes less than \$15.00. Karen Lane, TAC said, if the budget is not adopted then the tax rate cannot be adopted because of the change for elected officials, it would have to be re-published. Joyner said, you would be adopting a budget that you do not know the numbers on. Commissioner Driskell said, revenue is going to be \$100,000 and if we give the 3% to all employees that is \$180,000 putting us over what we are behind already on our revenue. Joyner said, because of the legality of the prior years you have amassed a reserve and fund balances to tie you over on less generating years. At some point you need to start using some of your reserve established on the past eight or nine years so to keep a smoother operation. Commissioner Driskell said, so you are suggesting we pass a deficit budget, Joyner said, you are not passing a deficit budget. If you look at your latest fund balance, spread sheet, the general fund has in excess \$187,000. The deficit budget is in the road and bridge funds and that is because you have accumulated so much in reserves, in order to tap into your reserves, you would have to pass a deficit budget. This budget is not presenting a deficit budget in the general fund.

Commissioner Cannon said, I guess we have time to change this before the end of the month and said to Joyner since you put the pay increases in the publication which we were not advocating. Joyner said, the Budget Officer asked me to put it in there. Commissioner Cannon okay, but we want to take it out and we do not need to take an action on the budget, he said. Commissioner Driskell said he would like to rescind his first motion and make a motion not to pass the budget. Commissioner Cannon seconded the motion not to pass the budget. Judge Leago said we have a motion and a second not to adopt the Fiscal Year 2020-2021 Madison County budget and called for a vote. See attached.

ITEM 21. Discuss and consider action on adopting Tax Year 2020 Maintenance and Operations Tax Rate of 0.5500/\$100 valuation and Tax Year 2020 Debit Service Tax Rate of 0 valuation of the total Tax Year 2020 Tax Rate of \$0.5500/\$100 valuation. Motion should be made in the following form: "I move that the property tax rate be decreased by the adoption of a tax rate of .55/\$100 valuation, which is effective a 2.17% decrease in the tax rate".

Judge Leago said the Fiscal Year 2021 Madison County Budget did not pass, so this agenda item will be tabled.

ITEM 22. Discuss and consider action on ratifying that the adoption of the Fiscal Year 2021 Madison County Budget will raise more total property taxes than last year's budget by 0.04%, an increase of \$2,427. The property tax revenue to be raised from new property added to the tax roll this year is \$92,422.

The Fiscal Year 2021 Madison County Budget did not pass, so this agenda item will be tabled, Judge Leago said.

ITEM 23. Discuss and consider grant application to Center for Tech and Civic Life for COVID-19 to cover unprecedented expenses of 2020 elections. See attached.

Janet Boone, Election Administrator said, an opportunity is available for grant application with Center for Tech and Civic Life for COVID-19 for a \$5,000 grant to assist in election expenses. She requested Commissioners' Court approval to apply.

Commissioner Cannon moved to approve EA's request; Commissioner Driskell gave a second; and Judge called for a vote.

ITEM 24. Discuss and consider approving final minor plat recorded in Volume 1297, Page 42, Number 84034 of the Madison County Records. Located in the Ira C. Shute Survey, Tract 10, Abstract 0206. Directions to Property: Just East of the Madisonville city limits, along Main Street/State Highway 21, known as 911 address 3475 State Highway 21E (Tract One) and 3525 State Highway 21 E (Tract Two), Madisonville, Texas 77864 of the Madison County Records. See attached.

Bunny Unterreiner, Assistant 911 Coordinator explained this is a land division of property east of Madisonville City Limits, previously Top Line Rental property, being divided into two parcels. City of Madisonville maintains an easement to its Lift Station at the back of these properties. The City of Madisonville has chosen not to exercise their right to ETJ determinations. This division requires Commissioners' Court approval because it does not meet any exceptions in our subdivision order. ITEM 25. Discuss and consider approving final minor plat recorded in Volume 1736, Page 132, Number 111081 of the Madison County Records. Located in the Job S. Collard Survey, A-10, the E. Arriola League Survey, A-4, and the W.W. Ballard League Survey, Abstract A42, being part of a call 1022.49 acre further divided into a 200-acre tract previously. Directions to Property: South of Madisonville, known as 911 address 2505 State Highway 90 S, Madisonville, Texas 77864, and a new address to be determined for the residual. See attached.

Bunny Unterreiner, Assistant 911 Coordinator explained this property is located south of Madisonville, a large parcel of land previously divided. Currently, they have taken some land out of their LLC name and put it into their own names with the intention of selling 91.69 acres. The division requires Commissioners' Court approval because it does not have the minimum footage required along a public roadway, however an easement is provided for access to the property.

Commissioner Cannon asked if we would be getting the same service as we currently get and save the county \$1,000 monthly. Cuevas said exactly.
