ITEM 25. Susanne Morris, County Clerk explained her request for the court to accept one quote for a building project in county clerk's office record room. Two other contractors looked at the project but never returned with a quote, so I am requesting approval of B'n'R Enterprises. The reason for this project is to correct a building mistake when Courthouse Annex was constructed. Newly preserved record books do not fit properly in the shelving so they need to be removed and new shelving reinstalled. Payment for this project will be funded by County Clerk's Record Management and Preservation Fund.

ITEM 28. Discuss and consider submitting a Hazard Mitigation Grant Program (HMGP) application, utilizing contract administration/engineering as needed, to complete an updated state and federally approved Mitigation Action Plan for all of Madison County. See attached.

Shelly Butts, Emergency Management Coordinator explained that many federal grants related to previous disasters or mitigation funds have additional requirements that applicants must meet to be considered for funding. Several of these and other grants require that applicants maintain a current Mitigation Action Plan. Our current county-wide Mitigation Action Plan needs updating. This is a huge undertaking and Butts suggested that we contract with a planning, administration/engineering firm to assist in bringing our plan up to date and have it approved at the state and federal levels. The estimated cost for hiring a contractor to complete the process and plan, without utilizing a federal grant is near \$55,000. The cost-share estimate for a contractor to complete the same process, but also applying for the securing a federal grant to do so, is near \$25,000. Madison County would ask the participating cities Madisonville and Midway to pay some portion of the matching fund cost. Butts stressed that this is a plan that could help us identify shortfalls, challenges, and possible projects that could mitigate, or lessen damages in the future. Eventually funding these mitigation projects could make future damages less significant. Judge Leago said nearly five billion dollars has been granted to the state from the federal government and a large portion of this money is going to fall under this Mitigation Action Plan as a condition of applying. Counties having the plan will be considered for future disaster needs, counties who do not have the plan will not be eligible. Commissioner Cannon asked how the county would pay for this Mitigation Action Plan application. Butts said there's approximately \$20,000 in reimbursement fees due the county from recent disasters. Those funds might be considered as a portion of the match.

Commissioner Cannon made a motion to submit a Hazard Mitigation Grant Program application, utilizing contract administration/engineering to complete a Mitigation Action Plan for all of Madison County; Commissioner Driskell gave a second; and Judge called for a vote.
