ITEM 11. Safety Meeting Monthly Report - Lynn Jeffries

Jeffries reported on October 2019 events. Joe Szewczyk, Risk Control Consultant, Texas Association of Counties (TAC) presented a Fire Safety program for county employees October 1-2, there were 16 in attendance. Five permits totaling \$260 were issued to the Mushroom Festival vendors and four septic system applications totaling \$920 were issued. ITEM 18. Canvass the votes from the 2019 November Election.

Janet Boone newly elected Elections Administrator presented the Canvass of General Election held on November 5, 2019, State of Texas Constitutional Amendments. The election went smoothly with 1,137 of the county's 7,428 registered voters, 15.3%, voting, Boone said. Judge Leago, Presiding Officer of Canvassing Authority certified that the figures on the tally sheets correspond with the figures on the returns. A copy of the Canvass Results Report and certified copy Canvass of General Election is recorded in these minutes.

ITEM 19. Discuss and consider action on the Resolution for the FY2020 Madison County Formula Grant Program Application from the Texas Indigent Defense Commission to provide improvements in indigent defense services within Madison County.

Judge Leago explained this covers the indigent defense program in our county, what we provide which is mandated by the state. Toni Joyner said this is an application for our county to get some reimbursement for indigent defense cost. It doesn't cover much of the cost, we spend some \$150,000

yearly on indigent defense. Judge said unfortunately this number is growing.

# ITEM 24. Discuss and consider longevity pay for elected officials.

Judi Delesandri, Treasurer read from the County's Personnel Policy manual, "Longevity pay will be paid annually in December of each year or a date established by Commissioners' Court." Elected officials are salaried employees and paid on a monthly basis, so their longevity payment is not paid until December 31st. Delesandri is asking the court to consider changing the policy for salaried employees to receive longevity pay on November 30<sup>th</sup> each year. All other employees who are paid hourly will receive their longevity pay the first payroll of December in time for Christmas shopping, she said.

Commissioner Driskell made a motion to approve longevity pay for elected officials on November 30<sup>th</sup> each year; Commissioner Cannon seconded the motion; and Judge called for a vote.

# ITEM 25. Discuss and consider county employee salary scale.

Commissioner Cannon said this needs to be discussed due to the 4% increase given to employees this budget time and asked Toni Joyner, Auditor to explain. She said the court needs to try and establish a cap on certain pay grades. There is a compensation schedule in place that shows each different pay grade and the range of salaries in each grade. Each year that compensation schedule is to be reviewed by commissioners' court and those ranges decided on by the court. In years past the adjustments were made to that scale based on what the budgeted adjustment was, and the maximum side of that scale was budgeted on whatever across the board general salary increase was made during the budget process. The minimum side of that scale was adjusted by fifty percent. During this budget process it was determined that automatically adjusting the maximum side of the pay scale was not the avenue commissioners' court wanted to take. It was not going to be a given anymore. The commissioners' court will review the pay scales and set limits. A 2020 compensation pay grade schedule has not been established. Commissioner Driskell says the maximum side of the scale should be capped. Joyner said you will have to make decisions on some employees who are outside compensation scale, today's discussion is to establish what commissioners' court wants the 2020 compensation scale to be. Judge Leago said today we want to take an action on the cap. Motion was made by Commissioner Cannon for compensation schedule be adjusted by 2% on the minimum side of the scale and the maximum side of the scale to stay levied with no changes; Commissioner Driskell gave a second; and Judge called for a vote.

ITEM 27. Discuss and consider bids for the Texas Hazard Mitigation Assistance Project funded through the Texas Division of Emergency Management (TDEM).

To be eligible for a grant you must have a mitigation plan which we have with Texas Association of Counties (TAC) but it is expiring, said Donna Cuevas, Assistant to the Judge and Emergency Management Assistant. It was decided that Emergency Management would go out for three bids for Hazard Mitigation Plan. Three proposals were received, and a Scoring Committee was formed for review and scoring of all three proposals. A copy of the three proposals and score summaries is recorded in these minutes. Judge Leago said an expanded version to this is the State of Texas was awarded some five billion dollars in grant money. This grant is strictly earmarked for future mitigation events. Grant Works was scored by the committee as the choice for the mitigation plan and makes this recommendation to the commissioners' county for its approval.

Commissioner Driskell moved to approve Grant Works for the Texas Hazard Mitigation Assistance Project; Commissioner Wiseman seconded the motion; and Judge called for a vote.

ITEM 29. Discuss and consider quotes from Dependable Generators and Stateline Power Corp. for maintenance agreements for generators at Annex and Courthouse.

Judge Leago discussed the generator located at Madison County fairgrounds needing repair. Several years ago, the county acquired the generator with grant funding and made an agreement with Madison County Fair Association to locate the generator there. The generator and fairground facilities are to be used in the event of disaster and emergency events Judge explained. Two quotes were received from service companies, one was described in detail and the other was not. Judge suggested to table this agenda item until a better description could be made for this service including a contract for annual service of generators at Courthouse and Annex.

ITEM 30. Discuss and consider hiring full-time employee from December 1, 2019 – January 21, 2020, for training period to replace the current deputy treasurer whose last day will be January 31, 2020. Judi Delesandri, Treasurer said "I am pleading for the court's permission to allow me to use contingency funds in order to get a fulltime employee in place with 60 days training to replace current deputy treasurer, Mike Bishop who is retiring January 31. 2019. Bishop prepares the county's payrolls, Human Resources, assists with accounts payable and other duties. My thoughts are to pay the new employee \$18.00 hourly and increase pay to \$20.00 February 1, 2020. I would like to post the position and have someone in place by December 1, 2019." Commissioner Driskell suggested a starting pay of \$16.00 hourly, but if a more qualified and experienced person applies for the position, then make a request to the Salary Committee for approval of \$18.00 starting pay. Judge Leago said this will give Delesandri ability to negotiate an hourly pay. Delesandri said there are five pay periods between December 1, 2019 and January 31, 2020, so she would request monies from contingency fund.

Commissioner Driskell made a motion to approve; Commissioner Wiseman seconded the motion; and Judge Leago said we have a motion and a second for treasurer to begin a search for a fulltime employee to begin December 1, 2019, and work through January 31, 2020 as a training period, all in favor.
