EDUCATION & CERTIFICATIONS: Applicant must have a High School Diploma or GED Certificate. Applicant must possess a valid Texas driver's license. Must be able to communicate the English language both in writing and verbally.

GENERAL: Applicants must have knowledge of the Laws of the State of Texas as well as Federal Laws, Basic TCOLE Certificate, or TCOLE Certification as a Licensed Peace Officer, and must qualify annually with assigned firearms. Experience preferred, but not necessary. Must be physically fit and able to lift and move as the job requires. Applicant must be able to pass a drug test, be at least 18 years of age. Individuals must have a clear criminal history and be able to work shift work. TEXAS BASIC PEACE OFFICER certification and currently licensed by the TEXAS COMMISSION ON LAW ENFORCEMENT (TCOLE). SRO Certification is preferred but not required. Applicants who are not currently certified, will be required to gain certification prior as soon as possible.

DUTIES & REQUIREMENTS: The ability to work well with children from K-12 levels and. Patrol School Zones during the week and work routine patrol when school is not in session during the summer, school holidays, and/or as needed by the Sheriff's Office. Offer verbal instruction to students regarding Standard Response Protocols and Interaction with Law Enforcement Classes. Must be able to work effectively with other law enforcement and non-law enforcement personnel during periods of high, medium, and low stress situations. Must be able to perform law enforcement job functions during emergency situations, inclement weather, and other unsafe conditions. Must have the ability to maintain the highest personal and professional standards. Must be able to conduct investigations, field interviews and police interrogations. Must be able to perform to required standards in conformance with the rules, standard operating procedures, and policies of the Madison County Sheriff's Office. Must possess comprehensive knowledge of and ability to interpret Texas Statutes, federal laws, and local ordinances. Must have the ability to write reports and use computers.

COMPENSATION: \$19.08/hr for TCOLE licensed and TCOLE basic certificate. Pay increase with additional TCOLE certificates (ie: Intermediate, Advanced, Master). BENEFITS: Medical, dental, vision and life coverage are provided for the employee and paid by the County after 90 days of full-time employment. Sick leave, bonus leave, compensation leave, vacation leave, and holiday time provided. Take home unit available.
